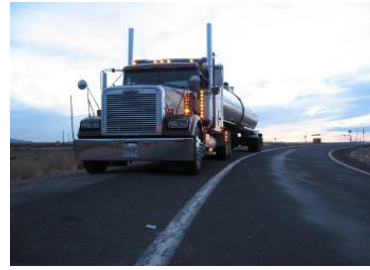

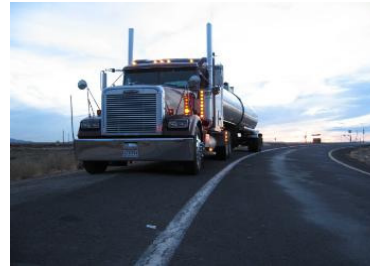
Credit Agreement: Your signature below means that in consideration of Alchem Chemical Company, Inc. extending credit to you, that you agree to the following terms of this agreement.
